She graduated from Owatonna High School, got her BS degree from St. Cloud State University and then graduated with honors from the William Mitchell College of Law.

She started out in her profession as a partner in her own private practice, Jones & Fischer. She also practiced law as an assistant county attorney, assistant public defender and was then elected in 2010 as the Kandiyohi County Attorney. In

2013, Fischer was appointed by Governor Mark Dayton as a judge for the Eighth Judicial District.

Fischer has been very active in the community serving on the Board of Directors for the Willmar Lakes Rotary, where she is currently serving as their president. She a former board member of Rice Memorial Hospital, Willmar Lakes Area Chamber of Commerce and past president of the Kandiyohi Area Family YMCA, and is currently an instructor at the Y. She is an active member of Vinje church, a past Girl Scout leader for many years and also taught Criminal Law and Criminal Evidence and Procedure classes at Ridgewater College.

They have a policy in place for promoting within as well as working with employees who wish to further their career path.

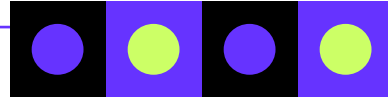
With 31 employees, 26 of them are women and three of which are serving in manager roles. They also have an insurance division which employs several women. North American State Bank promotes their

North American State Bank believes in community involvement. They host the free annual community paper

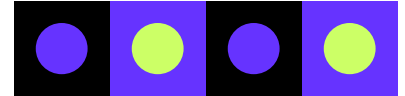

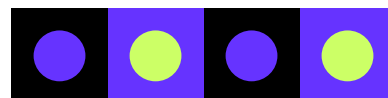
