Call to Order President Joni Fauchald called the meeting to order at 10.38am.

Roll Call Secretary Pro-Tem Beth Gibson Lilja presented the roll call.

Approval of Minutes The August 2015 minutes were reviewed. Motion to approve made by Beth Gibson Lilja, seconded by Julie Asmus. **Motion Carried.**

Treasurer Report Report presented by Faye Crane. There are no changes as there has been very limited activity. A listing of members was attached to the report. There was discussion regarding the status of membership numbers. There are 113 members paid to date. Dala has five new members after the last meeting but dues have not been sent. **Report will be filed for audit.**

Unfinished Business Limited Liability Insurance and Treasurer's Bond – Carol Masberg with Hays Companies in Minneapolis is seeking bids from various companies. These items are not in the budget but the payment can be made from surplus funds. Beth will continue to monitor this process.

Webmaster – Donna Brau has said that she will continue for now but will seek someone from Willmar to transition to the position. Dennis Benson from Willmar is the Webmaster. Local Organizations may send information to Donna at LAdirector@vinjchurch.com. Donna would like Local Organization information as soon as possible – pictures of officers, newsletters, dates of meetings, special events, contact person, location of meetings, etc.

WCDC Representative – Susan Jordahl-Bubacz attended the September meeting. Julie Asmus has agreed to be our new representative and she will contact Shirley about attending the October meeting.

Young Careerist and ID Programs – Discussion was held regarding these programs and how to implement them back into MBW. Perhaps some of the individual programs like Robert's Rules of Order (skit) could be used for the 2016 State Conference. We may need to explain to each Local Organization why it is important to have this training. Beth indicated that she served on by the BPW/USA Young Careerist and Individual Development National Committees and will provide her information to the Board. Beth has been tasked with the Young Careerist program for the State. The ID program could be used for Local Organization meetings. Joni indicated that she would be sending a listing of the Individual

Development Module Programs to the Local Organizations.

Michele was not present to provide an update of the Women of Today Program. She will provide information on how that organization manages its training programs. There is also a Woman of Distinction Award. The organization also provides high school scholarships.

Beth provided an update of the Minnesota Women's Consortium. The board discussed how it can work with them – perhaps the new director could be a 2016 State Conference speaker.

Faye provided the board with an update on the member database. Evette has not been receiving the information of new members – she just set it up initially but is not going to continue with the process. Since we switched to the new system, we no longer have older information like lapsed members. We do not have a workflow for keeping track of new members. The board discussed the news of the database system. Kristina has volunteered to initiate the process. Information should start with the MBW Treasurer. Local Organization Treasurers should then send information to the State Treasurer. With this new process we would not need a database manager – the Local Organization Treasurers need to add to timelines to report to State Treasurer each month.

Presidents Call was held last Thursday and there were only two others on the call - Evette from Dala and a representative from Mankato, Tammy Ellis. Mankato is very excited. Joni sent out the agenda well in advance. Is this something we want to continue? We will give it one more chance for the November call and see what happens.

New Business Legislative update – Susan was not available for this meeting and there was not written report. What type of event should we have for the members? Do we want to partner with the Minnesota Women's Consortium for the Girls Rock the Capitol Program? Each Local Organization will need to determine the extent of its participation.

Meetings Planner – This is a new role for Julie and she is seeking assistance in determining her position and who will be helping her for the 2016 State Conference. This would be a conference and becomes a meeting if there needs to be changes to the Bylaws. What do we want from this event? We need to provide personal, professional and political sessions. We need to begin a budget. How about a murder mystery for the Friday night event?

Meeting Recess Joni called for a recess for lunch at 12:50pm.

Meeting Reconvened Joni reconvened the meeting at 1:22pm.

Bylaws Chair – Faye Crane indicated that there were no changes at this time. There was a question, however, about whether the State Conference should be every other year.

Finance Chair – Paul Hritz-Nobs mentioned that our budget was designed for 150 members this year. At this point, we will need to pull funds from surplus funds.
