# National Business Women's Week®

Business and professional women throughout the United States celebrated National Business Women's Week® (NBWW), October 19-23, 2015. We need to thank the women who fought for gender equality decades before diversity and inclusion in the workplace became a popular topic. This year marked the 87th anniversary of NBWW.

The event was a nationwide salute to all working women and provided us the platform to highlight the progress we have made, it also provided us the opportunity to discuss:

- 1) The needs of all working women: Companies with a diverse corporate structure are poised for greater success in today's complex global markets. We have made some significant advances. But there still exists an uneven representation of women and minorities in the executive suites and board-rooms.
- 2) Share information about successful workplace policies: Credit Suisse has a link to "Gender diversity and corporate performance"; Dan Schwabel has a link to "Why diversity matters in the workplace"; Compass Group has a link to "Diversity and inclusion-the face of our success"; Publix has a link to "Committed to diversity"; The Coca-Cola Company has a link to "Diversity, inclusion and fairness programs and policies"; and IBM Executive Research Study has a link to "Advancing women".
- 3) Raise awareness of resources available for women.
- 4) Highlight the progress made by women business owners.



The following is excerpted from . . .



*They chartered in 1980 with the largest charter ever for a local BPW unit — some 70 strong — and their track record shows the group has continued to grow and prosper since that time. In five short years, Willmar has produced a State Treasurer and District officers, chaired State Committees, won YCW District Competition, had a State IDP winner, and hosted a State Convention, district meetings, and the State Legislative Conference.*

*Surprisingly, it was a man that got the Willmar BPW started. Ollie Hagen, a local banker, had come from Austin, Minnesota, where there was a strong, cohesive BPW group in operation. He thought the same type of group was right for Willmar:*

*Letters were sent out to businesses soliciting interest and 17 women turned up at the first meeting. From then on, there was nowhere to go but up.*

*How do they do it? "Programs are the key," says Betty Shepperd, Willmar member and Minnesota's National and State Councilor for the Future of Women in the Workplace.*

*The group has broad-based representation on the Chamber of Commerce, United Way, School Board, Utility Board and Library Board, and on the Planning Commission and Police Commission.*

*This is what the group is most proud of. "There are more women on boards in Willmar than ever before," says Leola Erickson, former State Treasurer. "The political visibility of working women here is excellent."*

*Flexibility is another key element in Willmar's success story. "We let leaders lead," says June Benson. "One of our goals is not to get into a pattern that can't be broken. Each new president is different from the last, and the members accept the change in direction."*

*They also operate a speaker service available to local schools and other organizations.*

*And they get more back than they give. "What I like," says Betty, "is the opportunity to meet people from other professions."*

*Leola stresses personal growth. "I've been pushed to do a lot of things I hadn't done before," she says.*

*Others cite the benefits of a BPW support group. "Now when I miss a month, I feel out of touch," says [past president] Audrey Nelson. "It's fun to see members and the group prosper."*
