# National Business Women's Week®

When is National Business Women's Week? Since 1938 National Business Women's Week has officially been celebrated the third full week in October of each year.

When Did National Business Women's Week Begin? The first observance of NBWW was April 15-22, 1928. The first NBWW began with a nationally broadcast speech by Lean Madesin Phillips, the president of the National Federation of Business and Professional Women's Clubs (NFBPWC).

Although Phillips launched the first NBWW event, the idea for NBWW should correctly be attributed to Emma Dot Partridge, the executive secretary for NFBPWC (1924 through 1927).

Phillips stated in her speech NBWW was created "to focus public attention upon a better business woman for a better business world."

**NBWW Trivia** U.S. President Herbert Hoover was the first president to issue a letter recognizing NBWW and the contributions and achievements of workingwomen.

Why Wait? Any day is a good day to support business women. Simply by offering women equal opportunities, training, and advancement as their male counterparts enjoy is perhaps the best way to help women achieve even greater success.

#### Linda Laitala and Carol Jensen Elected Delegates to White House Conference

Carol Jensen, Rochester BPW, and Linda Laitala, Dala of Mora BPW, are among 20 delegates elected to represent Minnesota at the White House Conference on Small Business to be held in Washington, D.C. in June 1995. The conference is an opportunity for America's small business community to make its views known to the Clinton Administration and Congress. The two most recent White House Conferences on Small Business were held in 1980 and 1986.

Key issues to be discussed at the conference include capital formation, community development, environmental policy, human capital, international trade, procurement, regulation and paperwork, and taxation.

All delegates must be owners, corporate officers, or employees of small businesses (defined as having fewer than 500 employees).

The National Conference, to be held in Washington D.C., June 11-15, 1995, will feature daily issue sessions, official White House functions, speakers, and social events. The conference will conclude with the delegates ranking policy recommendations to submit to President Clinton and Congress.




# WOMEN in the Legislature — 68 out of the 201 seats in the House and Senate

It took until 1979 for the total women in the Minnesota legislature to reach 20 and grew fairly steadily until 2007 when if leveled off.


Today, women make up less than 34% of the state's legislators.

# Women Voters...We Really Do Rule

Election day is less than two months away and candidates would do well to pay attention to women.

History tells us that women vote in higher numbers than men do. We have in every presidential election since 1980 and the gap has widened over time.

In 2012 the difference in turnout was nearly 4 percentage points (63.7% of ladies voted versus 59.8% of men). If you look at women who have never married, the difference was more than twice as large. Women, it seems, really do run the world.

Why? One possibility might be that women deal with government more in their day-to-day lives than men do. More women live in poverty and are more dependent on services such as food stamps and child-care subsidies. Even among American women who aren't poor, women are more likely to be primary caregivers, which means they spend more time with teachers, eldercare workers, health-care providers. This additional exposure to government could make potential outcomes of elections more relevant.

However, this voter gap is not true within all age groups. For those under 65, turnout rates are higher among women. For those over 65, the reverse is true.

Ever since 1980, when women's turnout exceeded men's, another gender-related is noted; a greater share of women than men have voted for the Democratic candidate.

Whatever your political party of choice, whatever your gender, we encourage you to vote.

BPW is the voice of working women in Minnesota. We are a non-profit, non-political organization dedicated to helping women achieve economic self-sufficiency.
