## St. PAUL BPW Jane Peterson, president

St. Paul Business & Professional Women exercised discretion in sub-zero weather by canceling their scheduled January meeting.

At our February 12, meeting, speaker Marytina Lawrence of Princeton, MN, brought us an interesting program titled "Where Our Food Comes From." Later, we discussed recent news reports about school district's hot lunch programs pressuring students whose parents had not paid for their lunches, going so far as to berate the children, and even dumping the food on their trays into the trash. We resolved to express our collective opinion to the board of education.

"I am writing on behalf of the St. Paul Business & Professional Women, to express our members' concern over the reported St. Paul Public Schools' policy of denying hot lunches to students whose parents are unable to deposit sufficient funds to pay for their lunches.

"We strongly urge you to reconsider the district's policy of browbeating, shaming, and bullying these children who face hunger both at home and at school. A program of free or reduced prices should be an option. Please do not delay in resolving this issue."

March 5 we had the second of our series called "It's My Story" with businesswoman Joyce Maddox as speaker. She told us about her career as a flight attendant for Braniff Airlines, followed by vice presidencies at two twin city banks while serving on St. Paul's zoning board for 24 years, and she is the proprietor of a B&B.

- <u>How did your club incorporate the MBW Presidential theme?</u> **The MBW Theme Award** will be given to the club that best demonstrates the use of the Presidential theme.
- <u>Did your club participate in an internal or external mentoring program?</u> The MBW Mentoring Award will be given to the club that best demonstrates use of a mentoring program within the club or within the surrounding community.
- <u>What did your club do to recognize NBWW (National Business Women's Week)?</u> The MBW National Business Women's Week Award will be presented to a club that sponsored an event or function that was dedicated to featuring MBW during NBWW. The event should have received media attention and/or a political proclamation.
- <u>What did your club do to become involved in your community?</u> **The MBW Activism Award** will be given to the club that best demonstrates the positive impact and/or influence that their club or scheduled activities as per the mission of MBW regarding making their community a more equal venue on behalf of women or helping women to strive to be the best they can be.
- Is there someone in your club or someone in MBW that has done something they thought they could not do? The MBW Eleanor Roosevelt Award will be given to an individual who best typifies Eleanor's words; "You gain strength, courage and confidence by every experience from which you must stop and look fear in the face. You must do the thing you think you cannot do."

## dba MINNESOTA BUSINESS WOMEN (MBW)

#### ARTICLES OF INCORPORATION

In order to operate as a corporate entity under Minnesota Statutes, Chapter 317A, the following Restated Articles of Incorporation have been adopted by the Board of Directors.

#### ARTICLE I

The name of this corporation shall be the MINNESOTA FEDERATION OF BUSINESS AND PROFESSIONAL WOMEN'S CLUBS, IN-CORPORATED, located at 15725 N 2nd Ave., Plymouth, Minnesota 55447-4005.

#### ARTICLE II

This corporation is organized for the purpose of promoting and elevating the status of women in business and professions under Section 501(c)(6) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purpose, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purpose.

#### ARTICLE III

At all times shall the following operate as conditions restricting the operations and activities of the corporation:

- 1. No part of the net earnings of the corporation shall inure to any Member of the corporation not qualifying as exempt under Section 501(c)(6) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, nor to any Director or Officer of the corporation, nor to any other private persons, excepting solely such reasonable compensation that the corporation shall pay for services actually rendered to the corporation, or allowed by the corporation as a reasonable allowance for authorized expenditures incurred on behalf of the corporation;
- 2. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(6) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

#### ARTICLE IV

The corporation shall have one or more classes of members as provided in the corporation's bylaws. The management of the affairs of the corporation shall be vested in a Board of Directors, as defined in the corporation's bylaws. No Director shall have any right, title, or interest in or to any property of the corporation.

#### ARTICLE V

No Member, Officer, or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers, or Directors be subject to the debts or obligations of this corporation.

#### ARTICLE VI

At the time of dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, dispose of all of the assets of the corporation. In no case shall a disposition be made which would not qualify as a charitable contribution under Section 170(c)(1) or (2) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, in such manner as the Board of Directors shall determine.

#### ARTICLE VII

In witness whereof, the undersigned officer certifies that she has been authorized by the Board of Directors to execute these Restated Articles and further certifies that these Restated Articles correctly set forth all prior amendments to the corporation's Articles, subject to the penalties of perjury as set forth in Minnesota Statues Section 609.48 as if she had signed these articles under oath.

#### BYLAWS

#### ARTICLE I NAME

The name of this corporation shall be the MINNESOTA FEDERATION OF BUSINESS AND PROFESSIONAL WOMEN'S CLUBS, INC. (MFBPW), dba: Minnesota Business Women, also known as MBW.

#### ARTICLE II MISSION

The mission of Minnesota Business Women shall be: Working women working together to promote personal empowerment, professional development, and political awareness for the women of Minnesota.

#### ARTICLE III POLICIES

SECTION 1.	Minnesota Business Women shall be non-sectarian, non-partisan, and non-profit.
SECTION 2.	The mission and objectives of Minnesota Business Women shall in every case be the mission and objectives of all clubs thereof.
SECTION 3.	No individual, committee, or club shall represent the organization officially, either in correspondence, publication or in person, without the authority of the board of directors.

#### ARTICLE IV MEMBERSHIP

<ul> <li>SECTION 2. Active Members and Student Members shall belong to clubs. (Student membership is NOT 1 TORY at the club level.)</li> <li>SECTION 3. #### ARTICLE VI FISCAL YEAR

The fiscal year shall be June 1 through May 31.

#### ARTICLE VII BOARD OF DIRECTORS

- SECTION 1. The board of directors shall consist of the members elected, or appointed, by the clubs (see Article V, Section 6).
  - 1. The board of directors shall hold its first meeting during the month of June and shall elect a president, secretary and treasurer. The previous president will preside at the June meeting until the new president is elected.
- SECTION 2. A term of office shall be one year beginning June 1.

#### SECTION 3. Vacancies in office shall be filled as follows:

(a) In the event of death, resignation, or incapacity of the president, secretary or treasurer, the oard of directors shall, within 30 days, elect a new officer for the open position.

## SECTION 4. The board of directors shall transact the business of Minnesota Business Women. Specific duties shall be to:

- (a) insure that the treasurer and other persons entrusted with the handling of funds or property of Minnesota Business Women be sufficiently bonded;
- (b) be responsible for having an annual audit of all state funds performed by the auditor by July 31 of each year;
- (c) create a special committee when necessary to carry out a specific task which does not fall within the responsibility of any standing appointee; and
- (d) ratify appointments of standing appointees, special committees, and other appointments where approval is required.

#### SECTION 5. Meetings of the board of directors shall be held:

- (a) during the month of June (see Article VII, Section 1);
- (b) when called by the president;
- (c) when called by a majority of the board of directors upon written notice to every member;
- (d) by telephone conference call of the president or by a majority of the members of the board of directors;
- (e) quorum: majority of the board of directors including representation from at least ½ of the clubs (example: if there are 13 directors and 8 clubs...a quorum would be 7 voting directors representing a minimum of 4 clubs); and
- (f) no member shall have more than one vote and no voting by proxy shall be allowed.
- SECTION 6. A vote of the board of directors may be taken by phone, by mail, or e-mail, at the request of the president when necessary. Such a vote shall have the force and effect of a vote taken at a meeting. For conference call meetings, a roll call vote shall be taken.

#### ARTICLE VIII DUTIES OF OFFICERS

#### SECTION 1. The president shall be the principal officer of Minnesota Business Women and shall:

- (a) preside at the annual event, special meetings, and meetings of the board of directors;
- (b) be an ex-officio member of all committees;
- (c) appoint a parliamentarian, standing appointments, task forces, and special appointments, as needed, subject to the approval of the board of directors;
- (d) send to each member the official call to any special meeting at least thirty (30) days prior to the first day of the meeting;
- (e) require each club to submit names and addresses of club officers and chairs to the state president by June 1; and
- (f) appoint meeting/event personnel as needed.

#### SECTION 2. The secretary shall:

- (a) record the proceedings of all meetings. A copy of such minutes shall be furnished to the board of directors within two weeks following each meeting;
- (b) perform the duties of the president in the absence of the presiden; and
- (c) maintain current and two years prior records on site at all official meetings, with all information prior being turned over to the state historian.

#### SECTION 3. The treasurer shall:

- (a) be responsible for all monies of Minnesota Business Women;
- (b) collect state dues and fees from clubs and members-at-large;
- (c) present written reports at all meetings;
- (d) disburse funds only upon the approval of the president and/or the written order of the finance

#### chair;

- (e) serve as an ex-officio member of the finance committee;
- (f) file the annual tax statement before materials are turned over to the successor;
- (g) deliver to the successor all funds, securities and records not later than sixty (60) days after the close of the fiscal year (May 31);
- (h) perform the duties of the president in the absence of the president and the recording secretary;
- (i) collect from clubs and share membership records for club members and members-at-large with the appropriate positions or persons at state and club levels; and
- (j) return club dues to the club within 30 days of receipt of payment.

#### ARTICLE IX STANDING APPOINTMENTS

- SECTION 1. The standing appointments of Minnesota Business Women shall be auditor, bylaws, finance, legislation and membership.
- SECTION 2. To be eligible to serve as a standing appointment or member of a committee, a member must:
  - (a) be in good standing; and
  - (b) officially and publicly support the legislative platform.
- SECTION 3. Standing appointments shall be for a term of one year and may be reappointed.
- SECTION 4. It shall be the duty of the auditor to audit the financial records of all state funds within 90 days following a state function and immediately then submit the report to the board of directors. A full report of the annual audit shall be presented to the board of directors.
- SECTION 5. The bylaws appointee shall receive proposed amendments and shall prepare them for presentation to the board of directors and shall review club bylaws as requested for approval. The bylaws appointee will notify clubs of needed changes following any changes to the state or model club bylaws and remind them to send in their club bylaws for review within 3 months.
- SECTION 6. The finance appointee shall serve as a member ex-officio without vote on all committees whose program requires the expenditure of monies. Duties are to prepare an annual budget for Minnesota Business Women and to have general supervision of all expenditures.
- SECTION 7. The legislation appointee shall prepare and present to the board of directors the annual legislative platform. The board of directors, a club, or a legislation committee may propose changes to the state legislative platform. It shall be the duty of the appointee to receive proposed changes to the platform and to make recommendations on all proposed changes. The appointee shall implement the legislative platform adopted by Minnesota Business Women.
- SECTION 8. It shall be the duty of the membership appointee to promote, expand, stabilize and orient the membership.

#### ARTICLE X ANNUAL EVENT

- SECTION 1. Minnesota Business Women shall hold an annual event, the date and place to be determined by the board of directors.
- SECTION 2. Any member may register to attend any Minnesota Business Women event. A registration fee, if applicable, shall be paid by all members who attend any or all event sessions. Non-member registration fee will be an additional \$60.
- SECTION 3. In keeping with our mission statement, it shall be the focus of the state annual event to promote personal empowerment, professional development, and political awareness for the women of Minnesota.

#### ARTICLE XI SPECIAL MEETINGS

- SECTION 1. Special meetings may be called by the president or the board of directors or upon written request of ten (10) members. A special meeting of the membership shall be held to amend bylaws.
- SECTION 2. A written call must be sent to all members at least thirty (30) days prior to the meeting.
- SECTION 3. The call must provide time, place and exact purpose of the meeting.
- SECTION 4. The voting body shall consist of all members in good standing who have paid the meeting registration fee (if applicable). Any member may register to attend a special meeting. A registration fee, if applicable, shall be paid by all members who attend any or all meeting sessions.
- SECTION 5. No member shall have more than one vote and no voting by proxy shall be allowed.

#### ARTICLE XII PUBLICATION AND WEB SITE

- SECTION 1. The Minnesota Business Woman shall be the official publication of Minnesota Business Women.
- SECTION 2. The editor of the publication shall be:
  - (a) appointed by the president with the approval of the board of directors; and
  - (b) accountable to the board of directors.
- SECTION 3. The editor may appoint staff to assist in administration of the publication.
- SECTION 4. The board of directors shall determine the number of issues, publication and mailing dates of the publication, select the printer, and consider all matters relating to the administration including recommendations of the editor.
- SECTION 5. The state will maintain a Web site where the state publication will be available electronically.
- SECTION 6. The funds for the publication and Web site shall be included in the state budget.

#### ARTICLE XIII PARLIAMENTARY AUTHORITY

The rules of parliamentary procedure comprised in the current edition of Robert's *Rules of Order Newly Revised* shall govern all proceedings of Minnesota Business Women, subject to such special rules as have been or may be adopted.

#### ARTICLE XIV AMENDMENTS

SECTION 1.	Amendments to these bylaws may be proposed by the board of directors, by any five members of at least two clubs, or a bylaws committee.
SECTION 2:	All proposed amendments shall be sent to the state bylaws chair for appropriate presentation to the board of directors and at a special meeting held to consider the amendment(s).
SECTION 3:	Written notice of proposed amendments must be given to all members at least 30 days before the spe- cial meeting at which the proposed amendment is to be voted on. Amendments to these bylaws must be approved by two-thirds of those members present and voting.
SECTION 4.	A unanimous vote shall be required for approval of any amendment proposed from the floor of the meeting without prior consideration by the members. Such amendment must be submitted to the by-laws appointee.
SECTION 5.	When an amendment is adopted to the state bylaws which affects club bylaws, each club shall auto- matically amend its bylaws to conform.

#### ARTICLE XV DISSOLUTION

Upon dissolution of this corporation, all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to an entity that has qualified for exemption under section 501(c)(3) of the Internal Revenue Code and state tax regulations. The voting body will approve which entity that is. None of the assets will be distributed to any member or officer of this organization.

# **WOMEN IN MINNESOTA HISTORY, PART 5**

#### Mary Jo Igelstad, Historian



**Bertha Berglin Moller (1888- ??)**; Bertha's family came to Minnesota from Sweden. She married Charles Moller in 1910. In 1916 she began her career as a political activist. Bertha helped organize suffrage campaigns in North Dakota. In 1918 they moved to Minneapolis and she volunteered with the Minnesota Scandinavian Woman Suffrage Association, participated in the Minnesota

Woman Suffrage Association, and served as chair of the State Associations Congressional Committee.

Bertha knew there was struggle for the 19th Amendment. She staged suffrage ballets in Minnesota, North Dakota and Wisconsin. During these performances police began a new round of arrests. There were hunger strikes, force feedings and jail time. Moller was arrested 11 times and went to jail twice in 1919. She and 22 others were accused of lighting paper, oil, wood and rope for the "Watchfire for Freedom". Later Bertha and several others served 5 days for throwing Minnesota grown pine boughs into the Watchfire for Freedom in front of the White House.

Moller remained active in politics after the 19th Amendment passed. She was committed to another issue "child labor" and was publicity director for the National Child Labor Committee. In 1921 she enrolled in the U of M Law School to "seek legal equality for women...until they have equal representation, the chances are they will never receive justice in the courts". The Moller's moved to Chicago in 1923 and she transferred to Northwestern, but didn't graduate.



Marguerite Milton Wells (1872-1959); Marguerite was born in Wisconsin and lived most of her young life in Jamestown, North Dakota. Because she was able to dress and look like a boy, she was able to attend an all-male political caucus. She wrote about all she heard at these caucus'. In 1891 she entered Smith College. Her family finally settled in Minneapolis in 1902. In 1917,

she offered her services to the MWSA. Under the direction of Clara Ueland, they organized support from the Minnesota congressional passage of the 19th amendment. Wells directed the drive for the amendments ratification and Minnesota was the fifteenth state to do so.

The National American Woman Suffrage Association had the 1919 convention in St. Louis. National President Carrie Chapman Cott proposed the League of Women Voters. Minnesota organized a League of Women Voters before the 19th Amendment was ratified in 1920. Clara Ueland was the first Minnesota President and Marguerite Wells was the First Vice-President. In 1934 she became National President of the League of Women Voters. She stepped down as president in 1944. "The League exists...for the purpose of establishing a tradition of responsibility about government".



Alice Ames Winter (1865-1944): According to Alice, woman suffrage was a means to an end—not just a goal. She was president of the General Federation of Women's Clubs, served on national committees on disarmament and film, wrote articles on education, support for mothers and women's citizenship rights and other topics. She came to Minneapolis as the wife of a grain dealer Thomas Gerald Winters. They had two children and she became involved in the Minneapolis kindergarten movement. Winter was the

founder and first president of the Woman's Club of Minneapolis. The club wasn't a suffrage organization and several of its members were against the suffrage movement. Alice was Chair of the Women's Division of the Minnesota Commission on Public Safety. The Commission had been criticized for discriminating against German-Americans and post WWI critics. She was a strong supporter of Americanization programs. She helped work with child care, nutrition, better housing and citizenship rights besides her commitment to war work.

Alice was the president of the General Federation of Women's Clubs. In this capacity, she campaigned for more permanent places and presence in Washington D. C. for organizations. She also supported measures as the Child Labor Amendment, the Sheppard-Towner Act (mother's aid), and Indian Welfare Committee and the Women's Joint Congressional Committee. She was honored in Minneapolis with a "home demonstration house" where home economic techniques could be tried and the house was named after her.

After her retirement, she became a contributing editor for Ladies Home Journal Magazine. She also wrote novels and non-fiction. Alice died in 1944.



**Mabeth Hurd Paige (1870-1961)**: to quote Mabeth from the Minneapolis Tribune March 25, 1944 "In 1945 it will be a quarter of a century since we achieved political enfranchisement and in my opinion not nearly enough women are taking part in the country's lawmaking. I had hoped when I entered the legislature in 1923 that by 1943 no less than ten percent of the legislature would be women—yet I am now the only one" Mabeth was born in Newburyport, Massachusetts to Edward Hurd, a physician and Elizabeth

Campbell who was a semi-invalid. She told her parents "she was going to have a purpose in life even if it meant being an old maid."

Mabeth had an art career which she gave up to marry James Paige, a law professor at the University of Minnesota. She decided to study law, and James said this would make them "completely congenial". They had one child, Elizabeth. Mabeth filled her life with many activities: family, church and community—she never practiced law.

Clara Ueland asked Paige to serve as chair of the Minnesota League of Women Voters. There were over 400 representatives from many women's organizations for a planning meeting in October 1919. A set of bylaws and a constitution were adopted. Paige was part of the transformation of the National American Woman Suffrage Association to the National League of Women Voters. She represented the League at the Pan-American Conference in Washington D. C. When she came back to Minnesota, she pushed for women to enter politics. Her husband James gave his permission for her to run for the legislature under the name of Mrs. James Paige, but she campaigned under the name Mabeth Hurd Paige. She won the election by only 47 votes. She was a legislator for 22 years. Mabeth served on the Welfare, Education and Public Domain Committees. She had a 54 hour work week for women, established the fourth psychopathic hospital at Moose Lake, sewer construction in the Twin Cities for the pollution problem of the Mississippi River, environmental protection of Minnesota forests and lakes, and limits on interest on small loans.




Myrtle Cain (1894-1980): "...no group has ever impressed me so much and I always feel I belong to them even when I do not see or hear from them very often." This was Myrtle speaking to Alice Paul, Chair of the

National Woman's Party, 1951. When she was in her twenties, Myrtle dedicated herself to the suffrage movement. She marched with Paul in Chicago in 1916. They led the suffrage movement against the cautious, conservative to a radical strategy in the struggle for women. In 1922 she was elected to the Minnesota House of Representatives as one of the first generation of women legislators. Cain made an impression with two bills: 1) the anti-Ku Klux Klan bill which passed; 2) a bill titled "Granting Equal Rights, Privileges and Immunities to Both Sexes" which didn't pass. When the equal rights bill was introduced to the House, a motion was made to postpone it indefinitely-motion carried. She ran for re-election in 1924, but lost by 39 votes.

Cain now started a career in the Farmer-Labor Party till the merger in 1949 which created the Democratic Farmer-Labor Party (DFL). The Labor win of the Farmer-Labor party didn't support the equal rights bill. She contacted Alice Paul and Arvonne Fraser and they worked together in the DFL office. They had great education and experience, but were paid less than their male counterparts. In the 1960's, new feminists publicized the equal rights movement. This is now the Equal Rights Amendment (ERA). Cain was a supporter of the amendment and was also involved in Eugene McCarthy's anti-war campaign in Minnesota. Myrtle Cain became known as a "Founding Mother".

On August 26, 1970, which was the fiftieth anniversary of the 19th Amendment, the Minneapolis Tribune interviewed Cain. "It's just the same as the opposition they gave the suffrage movement. It's ridiculous that here in the year 1970 we have to eliminate discrimination". February 12, 1973 was declared Myrtle Cain Day by Governor Wendell Anderson for her decades of public service.



## Melinda "Mindy" (Kunz) Bowman

Melinda "Mindy" Bowman, 59, of Bemidji, Minnesota, died February 4, 2014, at her home. Funeral Services were February 8, 2014, in Bemidji.

Melinda Ann Kunz was born February 21, 1954, in Minneapolis, Minnesota, to Robert Louis and Donna (Berggren) Kunz. She attended John James Audubon Elementary School until her family moved to Bemidji when she was 11 and purchased a wreath making business. Mindy graduated from Bemidji High School in 1972 and Concordia College in Moorhead in 1976.



Mindy was an original Washington staff member for Congressman Arlan Stangeland in 1977, worked on the Ronald Reagan campaign working with Elizabeth Dole, and worked for the Deputy Secretary of Transportation, Darrell Trent. In 1981, she returned to Bemidji to help her mother with her business, Minnesota Woods Products, where she just completed 33 years. In 1993, Mindy and her husband Don opened Surplus Outlet, a retail store in Bemidji, selling general merchandise, upholstered furniture and bedding.

Mindy was a member of the Business and Professional Women (Minnesota Business Women) where she held many positions at club and state level (see list below). She was also a member of the Bemidji Eagles Club and the United Methodist Church. Mindy was co-chair of the Headwaters Quilt Guild at the time of her death. Many good friends were made with those who shared the love of quilting.

She is survived by her husband of 28 years, Don Bowman of Bemidji; sons, Dustin Bowman of Mankato and Chris Bowman of Minneapolis; brothers, Gary (Diana) Kunz and Tim (Carlene) Kunz both of Bemidji; step-children, Nicole (Jason) Nordby, Tom (Whitney) Bowman and Katie Bowman and mother-in-law, Agnes Bowman of Fergus Falls.

# Motion for Dissolution of state organization:

I move the dissolution of Minnesota Federation of Business and Professional Women's Clubs Inc.:

Whereas all assets remaining after payment of all costs, expenses and obligations are to be distributed to qualified 501(c) 3 entities, I further move that the meeting recess to convene as a committee of the whole for the purpose of discussing the dissolution of the Federation and to identify who will be responsible for guiding the process.

#### RATIONALE:

- For the past 20 years membership in our organization has gone down
- The number of clubs has declined
- Each year recruiting officers for state offices has been more and more challenging
- Attendance at state functions has steadily deteriorated even though more emphasis was put on designing programs that would be interesting and valuable for members
- If the state organization is not adequately supported by the members it is time to dissolve.

## **Rationale for the substitute bylaws:**

Because we know that so many people have invested so much time (heart, soul) into this organization, we feel that there should be an alternative available so that we can have a more streamlined federation that can hopefully appeal to younger people.

The basic premise is changing over to a board of directors (BOD) driven state where the BOD would elect a president, secretary and treasurer from the BOD members and be in charge of overseeing virtually everything except changing bylaws. The dues are cut in half since the state doesn't need money...if we were to disolve, we would spend a great deal of angst deciding which (or how many) 501(c)3 would get our money. Should the membership want to keep the state going, this document could give them the vehicle to be able to spend down the monies to the educational benefit of the members. It would also allow a smooth flow into the next fiscal year.

By empowering a BOD, whose members come selected by their clubs, there should be more "ownership" from the clubs. By having a small BOD elect the officers from the core group, we eliminate the search for "someone, anyone" to step forward. The membership will also know that they do not have to sit through the "nuts and bolts" of the organization unless they want to and that there will be an event once a year that will give them something to attend at no cost, or a low cost, as the state certainly has the money to put on an event and absorb the cost as long as it fits our mission and purpose. Since we thought that there should be "some" dues, they are reduced to half and the member-at-large dues are lowered to what the highest total club dues would probably be.

A quick breakdown of the major differences from our current bylaws:

- No executive committee, nominations or elections
- No state convention/annual meeting
- Board of Directors (see next bullet) ...
   A president (to preside), secretary (take minutes) and treasurer (pay bills) elected by the BOD at a June meeting of the BOD.
- Clubs (in May) will elect or appoint member(s) to serve on the BOD each year based on the clubs' membership as of April 30

5-19 members	=	1 director	
20-29 members	=	2 directors	
30 + members	=	3 directors	
(based on the above schedule and our current membership totals -			

2014-2015 could have 13 directors)

- Annual Event (planned by the BOD or a task force): the event should be designed to involve the members by highlighting our "mission" (even if only 20-30 members show up, those 20-30 will benefit from the event).
- A special meeting only if bylaws need to be changed or the members later decide to dissolve the state (which would be the "final" bylaws change) ... this would not be a BOD meeting ... all members in good standing could/would/should vote.
- These streamlined substitute bylaws would serve to keep the state organization viable for the future time when the bylaws can be expanded back to include some of the past features or reincarnated again to meet the needs of a future we can only dream of at this time.
- Let's not forget that Minnesota BPW/MBW should be celebrating 100 years in 2020!
